
- * For you to redeem the Payday 50% Deposit Bonus, the below steps have to be taken:

- * For you to be eligible for the Payday 50% Deposit Bonus, the below criteria have to be fulfilled:
 - 1. The Payday 50% Deposit Bonus Promotion Period will be from 25th February 2023 (12:00AM GMT+8) until 28th February 2023 (11:59PM GMT+8).
